DESCRIPTION

Immuno-DMG Chewable is an advanced nutritional supplement that combines 10 powerful nutrients including N-Dimethylglycine (DMG) and Larch Tree to help support immune wellness. It also includes a purified D-fraction from Maitake Mushroom and Beta 1, 3 Glucans along with Vitamins D, C, E, Zinc and Black Elderberry.

FUNCTIONS

There are many factors that can challenge a healthy immune system including; stress, exposure to toxic compounds, allergies, bacteria, viruses, irregular sleeping patterns and a poor diet. The immune system is very complicated and is comprised of many highly specialized immune cells, each of which play various roles in maintaining and regulating normal, healthy immune function. Immuno-DMG Chewable is specially formulated to help support the total immune system. The components of Immuno-DMG of note are: astragalus, a Chinese herb that has been extensively studied since the 1970s for its ability to support the immune system; black elderberry which serves as a source of anthocyanidins that are thought to have immune modulating effects; DMG which according to numerous studies, can help maintain a strong immune system by supporting increased resistance to invading microorganisms and enhancing antibody and lymphocyte production; and Larch Tree, a source of Arabinogalactans, which support the immune system in its production of immune cells and supporting healthy cell replications.

Maitake mushroom has a long history as an immune support product and serves as a highly concentrated source of Beta-1-6 Glucans which research has found support the body's first line of defense, including macrophages and natural killer cells. Maitake D-Fraction has been extensively researched, and is one of the most comprehensive immune support ingredients available. It is the only Maitake ingredient that has been approved by the FDA for conducting phase 2 clinical studies. Beta-1-3- Glucans are shown to activate B-Cells and T-Cells. Although derived from yeast, it does not contain yeast proteins. The Beta Glucans are made from the cell walls of baker's yeast, which is then purified and free of allergenic material.

Vitamin C is a powerful antioxidant that helps protect cells from oxidative stress. It also supports the production of antibodies, a major function of the immune system. Vitamin E is a powerful antioxidant that supports the immune system in its function to support natural killer (NK) cells and B cells, which create antibodies. Vitamin D is an immune system modulator to support healthy T Cell and macrophage responses. Finally, Zinc is essential for a healthy immune system. It is required for the development and activation of T-Lymphocytes, a kind of white blood cell that helps fight infection.

INDICATIONS

Immuno-DMG Chewable may be a useful dietary supplement to help support immune response and function, particularly during times of stress or during the cold and flu season.
